PL110/12 APOLOGIES FOR ABSENCE K Cooper & D Fernee.

PL111/12 DECLARATIONS OF INTEREST Cllr. Gardiner in respect of planning application 2012/1228 being a personal acquaintance of the next door neighbour.

PL112/12 ITEMS RAISED BY MEMBERS OF THE PUBLIC

Cllr. Hockaday – planning application 2012/1201 – resident has concerns over the narrow busy road, blind bend and the nearby busy roundabout.  
Mrs Riccardi – planning application 2012/1201 – wishes to wait for conclusion of Local Development Framework site specific consultation. Concern that development was on a Greenfield site.

Mrs Wells – planning application 2012/1228 read out statement in accordance with letter submitted objecting to plans. Major concerns over noise. Secretary of ex Service Mens Club explained that they had installed the patio area to provide a safe environment for children and families. Cllr. Roberts advised that there was a court order in respect of noise and that the application breached planning policies IMP9 & IMP10. Application should be refused or there should be a restricted use of the patio area. Mr Howes chairman of the ex Service Mens Club responded that part of the premises were licensed for 4 amplified acts per annum and another room had a sound limiter installed. The rear area behind the building had tables and chairs before the patio area was installed.

Mrs Barrett – planning application 2012/1226 – had been the previous owner of the plot on which the applicant had built a single property and that this land should be the garden. South Norfolk Council had previously determined that only 1 dwelling should be built on the site. Mrs Clark raised concerns regarding the close proximity to her property and its detrimental effects on her privacy, she had tried to purchase the land but to no avail. Mr Nichols concerns over traffic.

Mr Walker – planning application 2012/1231 concerns that signs are causing accidents.

Mr Walker – agenda item 7 concerns that consultation event is 3.00pm – 7.00pm and that people will not be able to attend.
